ACCEPTANCE OF THESE TERMS

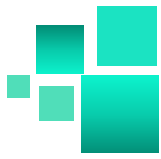
This Privacy Policy is incorporated into and subject to DgDiary Terms of use. If users do not agree to the terms of this Privacy Policy Statement, please do not provide us with any information and do not use this site / app / service. By using DgDiary and voluntarily providing personally identifiable information and on DgDiary, users consent to the collection and use of such personally and identifiable information as set forth in this Privacy Policy.

INFORMATION COLLECTED

If registration is requested, Users agree to provide accurate and complete registration information. At the time of registration Users may be required to provide on DgDiary certain information which includes your name, address, phone number, and email address, collectively referred as “User Profile content”. Upon registration on DgDiary, Users may be assigned one or more login IDs and password that will enable Users to access DgDiary. Users shall take responsible precautions to protect against theft, loss or fraudulent use of such IDs and passwords, and Users are solely responsible for any losses arising from another party’s use of such IDs and passwords, either with or without User’s knowledge. The Children’s online Privacy and Protection Act (“COPPA”) requires that online service providers obtain parental consent or provide notice before they knowingly collect personally identifiable information online from children who under 13. We do not knowingly collect or solicit personally identifiable information from a child under 13, except in the following circumstances.

- We may collect a child’s name (first, middle and/or last name), date of birth, email address and /or telephone number, and the child’s parent’s telephone number and/or email address to provide notice to parents that we may contact their children for the purpose of providing the services through DgDiary for which their teacher has signed up for. We may collect personal information through the services from a child under 13 where that student’s school, district, and/or teacher has parental consent for that child to use the services to disclose personal information to us, for the use and benefit of providing services through DgDiary. We are not responsible to verify that the school / teacher has obtained the consent.
- If you are a teacher or the signing authority at the school, you represent and warrant that you have permission and authorization from your school and /or district to use the services, and for purpose of COPPA compliance, you represent and warrant that you are agreeing to these terms on behalf of

your school and/or district.

- You may be required to provide valid school credentials and a valid school email address to verify your identity to access and use certain features of the services.

If we come to know that any personal information has been collected from a student under 13 other than pursuant to the above, or if we learn that a student under 13 has provided personal information beyond what we request from her or him, we will delete that information as quickly as possible. If you believe that a student under 13 may have provided us personal information in violation of this paragraph, please contact us at info@dgdiary.com

We receive and store any information you knowingly enter on the services of DgDiary, whether via computer, mobile phone, other wireless device, or that you provide us in any other way. This information may include Personal Information such as your name, phone number, email address, photograph, and, in certain circumstances, your school affiliation, which is used to provide notifications to users via the Services of DgDiary from a teacher, school, and/or district (“alerts”), and any other information necessary for us to provide DgDiary services.

USE OF INFORMATION

User profile consent shall be retained by us only as custodian of such information and data. That such information and data shall only be used by for specific Users and not by us unless requested by the school/teacher in order to facilitate interaction among Users of DgDiary. By entering into this Agreement, Users agree to treat information about other Users of DgDiary strictly in accordance with the Agreement. If you are a parent of a child who is under 13, you always have the choice to no longer allow your child to receive such communications by contacting us at info@dgdiary.com

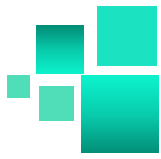
Any User may email us at info@dgdiary.com , if such user no longer wishes to receive communications from the services.

DATA INTERGRITY

We do not share, sell or rent users’ personally identifiable information to third parties. We will not share or distribute any user information with third parties expect as provided below.

1. When required to do so by law or regulation, or in response to a request from a law enforcement or governmental agency or authority or to establish or exercise our legal rights or defend against legal claims.
2. In order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to physical safety of any person, violations of our terms of use, or as otherwise required by law.
3. If we are required by or merged with other company, we will notify you about such an acquisition or merger and users being subjected to any different privacy policy.

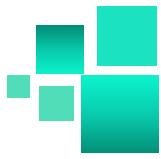
